

In the year 2019 – 2020, the Company has received a notice of penalty for non compliance of Regulation 6 (1) of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015. However the Company has suitably replied to the notice.

As per our observation this notice was issued primarily on account of typographical error in date of appointment of compliance officer to which the Company has replied to the exchange.

Subsequently vide exchange mail dated 21st January, 2021 the fine was waived by the exchange.

Other than this, to the Best of our knowledge no action was taken by SEBI or Stock Exchange against the Company. The Company do not have any subsidiary and hence the question of action against subsidiary does not arise. Further based on the declaration received from the Directors and Promoters, we hereby state that no action was taken on the promoters or directors by SEBI or Stock Exchange. 
