

Ahmedabad emerged as the most affordable Indian housing market of 2021

Ahmedabad, In its annual proprietary study, the Affordability Index 2021, Knight Frank notes that Indian markets are at their decadal best in terms of housing affordability. Ahmedabad emerged the most affordable housing market in the country with an affordability ratio of 20% followed by Pune and Chennai at 24% and 25% respectively in 2021. All markets, except Mumbai, are recorded to be well below the threshold of affordability set at 50% ratio. Mumbai was the only one that recorded higher than threshold affordability ratio at 53%, however, it has improved the most since 2011. Knight Frank's proprietary Affordability Index which tracks the EMI (Equated Monthly Installment) to total income ratio for an average household, has shown a meaningful improvement in

Noida: Parents demand closure of schools amid rising Covid-19 cases


Noida, Citing the spread of the Covid-19 infection among school-going children in the light of the new Omicron variant, the All Noida School Parents Association (ANSPA) shot a letter to the district inspector of schools (DIOS), Gautam Budh Nagar, demanding closure of schools in the district. Following an order issued by the Uttar Pradesh government, Gautam Budh Nagar DIOS Dharamvir Singh issued directives to all schools in the district regarding the continuation of physical classes albeit with the stringent implementation of Covid safety protocols. Yatendra Kasana, president of ANSPA, said physical classes should be discontinued and schools should go back to holding online classes. "Even the fully vaccinated individuals are at risk of contracting the Omicron variant of Covid-19, so how can parents take chances with the lives of their children, who are not vaccinated at all? We have written to the DIOS demanding closure of all schools and discontinuing physical classes amid rising cases of Covid-19 in the

PUNE: The Pune city police have found 1,270 candidates of Teacher Eligibility Test (TET) 2019-2020 suspected to have paid money to agents, and in-turn to the software company conducting the exam, in order to get on the qualification list. DK Shivakumar scolds man for trying to take selfie with him, cites Rajiv Gandhi

Noida, Karnataka Congress president DK Shivakumar on Wednesday scolded a man for trying to take a selfie with him in Mandya district. In a clip shared by news agency ANI, the Congress leader can be seen grabbing the mobile phone of the man and moving the device away from his face. Shivakumar later cited the assassination of former Prime Minister Rajiv Gandhi to defend his act. He said one cannot be sure what the other person is carrying in his hand. "You know what happened to Rajiv Gandhi. Sometimes, human anger and emotions come out, nothing wrong in that," the Congress leader said. He added, "I am not a suicide bomber belonging to Liberation Tigers of Tamil Eelam in May 1991 during an election rally in Karnataka. The incident resulted in the death of 14 other people.

This, however, is not the first time that the Congress leader lost his cool in public. In July, a video of him slapping a party worker after he reportedly tried to put his arms around the former went viral on social media. According to PTI, Shivakumar later asked the cameraman to delete the footage and asked the person to behave responsibly.

In a statement later, he did not deny the slapping, but asked if such acts (putting arm around) can be allowed simply because one is a Kanyarkata (worker). "What will others looking at it say?" he added. Last week, the Kanakapura MLA had torn a copy of the anti-conversion bill that was tabled in the Karnataka Assembly. The Congress camp had earlier walked out of the Assembly as a mark of protest against the bill.

Agency for extension of Metro to Greater Noida West to be finalised soon

Noida, The Noida Metro Rail Corporation (NMRC) on Wednesday said it will soon finalise the company for the construction of the 14.5-km long Greater Noida West Metro project. The NMRC opened the financial bids of three agencies, who have evinced interest in the construction of the project, on Tuesday. The corporation will soon finalise one of the agency to start work on the ground, said officials. The NMRC received the financial bids from GR Infraprojects Limited, which placed the lowest bid of ₹52.99 crore; Ashoka Buildcon Limited, which placed a quotation of ₹64.97 crore for the construction of the project and Sam India Buildwell Limited - the agency that was disqualified on technical grounds.

Kansal also inaugurated the completed Mandatory Works related with 130 KMPH in Vishwamitri-Dabhoi section including interlocking of 9 Level Crossing gates. At Vadodara, Shri Kansal conducted an intensive inspection of passenger amenities and staff facilities

Milind Ekbote, Kalicharan Maharaj, others booked for making 'provocative' speeches in Pune

PUNE: The Khadak police registered a case against religious leaders Milind Ekbote of Samast Hindu Aghadi organisation, Kalicharan Maharaj and others for allegedly making provocative speeches during a public program held in the city last week. Ekbote is one of the main accused in the Bhima-Koregaon riots case and had been arrested by the rural police on charges of inciting and delivering inflammatory speech ahead of the bicentennial celebrations of the battle of Bhima Koregaon. Policeman Somnath Dhage said, an FIR was registered on Tuesday at Khadak police station. The police organization of the inflammatory video clip which went viral on the social media and initiated criminal probe into the act. According to police, a program was organised at Natubaug maidan on December 19 to mark the occasion of the killing of Arzal Khan by Chhatrapati Shivaji Maharaj. The accused made statements that could incite people and hurt religious sentiments. The other accused booked in the case have been identified as Mohanrao Shete, Deepak Nanpure, Nandkishore Ekbote and Digendra Kumar. Kalicharan Maharaj had been booked by the Madhya Pradesh Police recently for his provocative and derogatory utterances against Mahatma Gandhi. A section of the state legislators had demanded that he be booked under relevant sections of carrying out anti-religious activities. The police in their complaint stated that the accused had made derogatory utterances regarding Christian and Muslim communities.

Greater Noida: Man cheats a person by promising job in Indian Railways, arrested

Noida, The Gautam Budh Nagar police arrested a 32-year-old man on Wednesday afternoon from Greater Noida for allegedly duping a person on the pretext of getting him a job in the Indian Railways. The suspect had already taken ₹1 lakh as advance from the person and finalised the whole deal for ₹7 lakh, said police. According to police, the suspect has been identified as Kartkeya Sharma, a native of Bulandshahr district, currently living in Beta sector of Greater Noida. Police have also recovered a car, which has a blue beacon and horns stickers of Government of India. According to the complaint lodged by the victim on Wednesday morning, he recently got in touch with Sharma, who assured to get him a job in the railways.
